

Making Impact – Make Schools Student Competition

Competition Rules

Carnegie Mellon University (“CMU”), with prize sponsorship from Dremel, a division of Robert Bosch Tool Corporation (“Dremel”), is announcing and administering the Make Schools ‘Making Impact’ student competition (the “Competition”).

To enter students are invited to showcase a project they prepared in the last year that highlights:

'How are you making impact on your campus, in your community or in the world with Making?'

Students can submit one project (collaboratively or independently prepared). Each project must include a short video (less than 3 minutes) of their work and a short description its development by May 31st, 2015. Winners will be announced during the Week of Making June 12-18, 2015. Specific submission requirements and deadlines are listed below.

Prizes:

The winner will receive a Dremel Maker Package that includes a Dremel Idea Builder 3D Printer, Fortiflex Heavy Duty Flex Shaft tool, the 8050 Cordless Rotary Tool, the 4000 Corded Rotary Tool, a VersaTip Butane Tool, a Dremel VersaFlame Butane Tool and the Dremel Saw-Max MultiSaw! Two runner up prizes of Dremel product(s) will also be awarded (which products will be determined in CMU’s discretion).

How to Enter & Deadlines:

To enter, go to <http://make.xsead.cmu.edu/competition/entries/> to complete the online submission. All submissions must include all required information and videos and must be received **by May 31st, 2015 11.59PM PST**. The submission process which will require the name of the designated contact who will submit the entry on behalf of all applicants, the name of the college or university entrants belong to, a project description and an active URL at which your video is viewable. All project members must be listed using a valid (institution) email address. All submissions are subject to and contingent upon compliance with these Competition Rules.

Judging:

CMU will select one or more judges for the Competition, which may include judges from CMU. The selected judges will review each submission in accordance with the theme and make a final determination. Finalists will be selected based on a) creativity b) originality and c) relevance to the theme. The selection of any finalist as a winner is also subject to and contingent upon compliance with these Competition Rules.

Submission Requirements:

Each submission must represent the original work of the entrants. Projects can be playful or serious but should be thoughtful, creative and original maker-outcomes. Videos must

be no more than 3 minutes in length. Only one submission per project team is allowed, and no person may enter the competition more than once (whether individually and/or as part of a team). Collaborative projects are welcomed, but the team must be eight or less people. All entrants (including all team members) must agree to these Competition Rules.

Winners:

Winners will be announced by CMU during the Week of Making June 12-18. These projects will also be featured on MakeSchools.org and may also otherwise be featured by CMU and/or Dremel, in their discretion, on websites or in other forms of publicity.

Eligibility, Terms and Restrictions:

- This Competition is open to active students currently enrolled in one of the Make Schools Alliance member schools (see: makeschools.org). *Don't see your school?* Send this link to your dean, provost or president and see if your institution can sign up. They can find the details at <http://makeschools.org/>
- All entrants, including all team members, must be 18 or older and legal residents of the United States. The Competition is void where prohibited.
- Unless otherwise specified, all references to an “entrant” or “entrants” in these Competition Rules or in the online submission form includes any and all persons entering the Competition, including all members of a team submission. The individual leading a team is the person listed as “primary contact” in the online submission form.
- If the submission is by a team rather than a single individual, the primary contact is responsible for obtaining the agreement of the remainder of the team members to these Competition Rules. A sample form to be used for this purpose can be found at the end of this document. Upon request, entrants must provide copies of these signed forms to CMU.
- All expenses associated with the development of the submitted projects are the sole responsibility of the entrants, including but not limited to arranging for an online site to which the video submission may be uploaded. If won by a team, distribution of prize items will be made to the entrant listed as the team leader in the relevant submission form, and any distribution or sharing among the entrants is the responsibility of the team to determine among them. Any federal, state, and local taxes, and like fees are the sole responsibility of the prize recipients. All videos must be the original work of the entrant (and/or the entrant must have permission to use any images, information or other materials that appear in the video that were not originally created by the entrant)
- If there are other people (non-entrants) that are involved with the submission and/or video (for example, they operated the video camera, appear in the video, etc.), entrants must have obtained appropriate written permission from these other people (and their parents/guardians, if they are under 18) to submit any submission materials and/or video that was filmed by and/or includes them into this Competition. A sample form to be used for this purpose can be found at the end of this document. Upon request, entrants must provide copies of these signed forms.
- Videos and submission materials must be suitable for publication (i.e., must not contain obscene or pornographic material, may not contain defamatory statements, may not invade privacy or other rights of any person/organization, must not in any other way violate applicable laws and regulations, must not contain any reference to any third party

trademarks/names/logos (unless the entrant owns them or has obtained appropriate permission to use them) and may not contain any copyrighted works or other materials that belong to other people (unless the entrant owns them or has obtained appropriate permission to use them).

- Entries containing prohibited or inappropriate content as determined by CMU, in its sole discretion, will be disqualified and will not be eligible to win a prize. By entering, the entrant agrees that CMU has no obligation to post the entrant's video and submission materials on makeschools.org or other site.
- By entering, you agree that persons designated by CMU will make the final determination as to whether entries are eligible to take part in this Competition and which entry is the winner.
- By entering, the entrant is hereby granting CMU the non-exclusive, worldwide, irrevocable, sublicensable right to copy, publish, use, reproduce, adapt, edit and/or modify the video and other submission materials (and to allow others to do so) for purposes of the Make Schools Student Competition and for promoting CMU and/or its Competition sponsors in any way, in any and all media, whether or not the submission is selected as the winner (including posting any selected submissions on makeschools.org). The entrant agrees that these rights are granted in consideration of entry into the Competition and are without any obligation on CMU to provide the entrant with any compensation or other consideration.
- Any prizes awarded are non-transferable and are not exchangeable for cash.
- This Competition is offered only in the United States and is governed by the laws of the Commonwealth of Pennsylvania. Any claims or disputes relating to this Competition or these Competition Rules must be settled exclusively in the federal or state courts located in Allegheny County, Pennsylvania. Entrant consents to the exclusive jurisdiction of such courts and waives any objection to the laying of venue in any such courts.
- CMU is not associated with Twitter, YouTube and/or Vimeo and no endorsement of this Competition by Twitter YouTube and/or Vimeo is implied or intended.
- All entrants that are initially informed that they are winners ("Potential Winners") are subject to verification of eligibility, compliance with these Competition Rules and verification that awarding of the prizes to the Potential Winner will not violate applicable U.S. laws or regulations. CMU reserves the right to require the Potential Winner to submit documentation in a form acceptable to CMU to substantiate such verification and compliance (including by all entrants on a team, as applicable). If a Potential Winner is not verified as eligible or is otherwise ineligible to receive the prize, the prize will be forfeited and may be awarded to an alternate winner in CMU's sole discretion. Entrants agree that CMU has the sole right to decide all matters and disputes arising from this Competition and that all decisions of CMU are final and binding. Status as a Potential Winner is confidential and if selected as a Potential Winner you may not disclose Potential Winner status to any other person prior to the official announcement of the winner by CMU. In the event that Potential Winner status is disclosed to any other person prior to the announcement of the official winner by CMU, you may forfeit your status as a Potential Winner and forfeit the prize.
- No liability or responsibility is assumed by CMU, its sponsors (including but not limited to Dremel, a division of Robert Bosch Tool Corporation), members of the Make

Schools Alliance, and/or any of their respective directors, trustees, officers, employees, agents, representatives, vendors, and contractors (collectively, “**Released Parties**”) resulting from and/or relating to any person’s participation (or attempted participation) in the Competition. No responsibility or liability is assumed by the Released Parties for technical problems or technical malfunction arising in connection with any occurrences which may affect the operation of the Competition (including but not limited to: hardware or software errors; faulty computer, telephone, cable, satellite, network, electronic, wireless or Internet connectivity or other online communication problems; failure of any entry submission transmissions to be sent to or received; lost, late, delayed or intercepted e-mail transmissions; inaccessibility of the URL at which the submission video was posted; traffic congestions on the Internet or the Competition entry web site or related sites referenced in these Competition Rules; and/or inaccessibility or unavailability of any email accounts used in connection with the Competition). By participating in the Competition, to the maximum extent permitted under applicable law, each entrant releases the Competition Parties from any and all claims, damages or liabilities arising from and/or relating to such entrant’s participation in the Competition (provided that this release does not relieve CMU of liability for failing to provide a qualifying winner with the prizes to the extent required under these Competition Rules).

- Except for the Released Parties (who can enforce the releases and other terms made for their benefit in these Competition Rules), there are no third party beneficiaries of these Competition Rules and they are intended to be enforceable only by CMU and the entrants.
- If any portion of these Competition Rules is determined by any court or governmental agency of competent jurisdiction to violate applicable law or otherwise not to conform to requirements of law, then the rest of the Competition Rules will remain in effect and the parties will substitute a suitable and equitable provision for the invalid/unenforceable provision in order to carry out the original intent and purpose of the original Competition Rules. These Competition Rules, the relevant online submission form, and any applicable Team Member entrant form represent the entrant’s entire agreement with Carnegie Mellon with respect to the Competition.
